## **The HL7 FHIR Foundation Announces Individual Memberships Now Available**

***Individuals can join at a discounted rate through March 2018 to support the  
adoption and implementation of HL7 FHIR worldwide***

**ANN ARBOR, MI , USA – October 30, 2017** – The [HL7 FHIR Foundation](#), a non-profit organization serving as the home to the Fast Healthcare Interoperability Resources ([FHIR®](#)) implementation community, today announced that individuals can now become a founding member through March 31, 2018 for \$250. As of April 1, 2018, the annual cost of the individual membership will rise to \$500. Corporate memberships are not available at this time.

HL7 FHIR is the specification enabling interoperability in healthcare today. The HL7 FHIR Foundation was launched in 2016 to promote the global adoption and implementation of the standard. It provides information, educational materials, tools, websites and project support that help the HL7 FHIR community collaborate, align and expand.

That work will continue at full pace within HL7, augmented by front line implementation experience from FHIR Foundation members."
